The book then examines exits and means of escape, seating layout and safety regulations, legislation, and stage sonery. The manuscript ponders on stage lighting, communications, film projection, performance organization, and public areas. Topics include access for the disabled, lavatories, restaurant, repair workshops, property store, scene dock, projection suites, amplifier racks, direct projection, stage management performance control system, and access to lighting positions over the stage. The book also reviews the restoration of old theaters, conference facilities, art centers and studio theaters, electrical and mechanical services, and administration. The publication is a valuable reference for design engineers and researchers interested in the design and adaptation of theaters.

Ventilation is the process by which fresh air is provided to occupants and concentrations of potentially harmful pollutants are diluted and removed from a space. It is also used to cool a space and as a mechanism to distribute thermally conditioned air for heating and cooling. It is a fundamental component of building services design since it plays a major role in the comfort, health and productivity of occupants. In addition, ventilation can contribute significantly to a building's energy load and, in some cases, can account for 50 per cent or more of total heating or cooling loss. To stem energy loss from uncontrolled air change there is growing demand for airtightness combined with demand controlled ventilation and heat recovery. The role and influence of building services engineers is undergoing rapid change and is pivotal to achieving low-carbon buildings. However, textbooks in the field have largely focused on the detailed technicalities of HVAC systems, often with little wider context. This book addresses that need by embracing a contemporary understanding of energy efficiency imperatives, together with a strategic approach to the key design issues impacting upon carbon performance, in a concise manner. The key conceptual design issues for planning the principal systems that influence energy efficiency are examined in detail. In addition, the following issues are addressed in turn: Background issues for sustainability and the design process Developing a strategic approach to energy-efficient design How to undertake load assessments System comparison and selection Space planning for services Post-occupancy evaluation of completed building services In order to deliver sustainable buildings, a new perspective is needed amongst building and services engineering designers, from the outset of the conceptual design stage and throughout the whole design process. In this book, students and practitioners alike will find the ideal introduction to this new approach.
