The Walter Scott Operas is a study of the approximately 50 operas that are based on the works of Sir Walter Scott, who, except for Shakespeare, inspired more operas than any other writer. Professor Mitchell's scholarly method is literary-historical (rather than "critical") and unabashedly antiquarian. He shows what happened to a Scott novel when it was turned into an opera and how that opera compared and contrasted with others based on the same novel -- all this leading to a fresh slant on Scott's characters and the structure of his novels. The Scott operas are all products of the nineteenth century, and indeed span the century from Rossini's *La Donna del Lago* (1819) to several done in the 1890s. The operas vary in style from typical early nineteenth-century romantic opera and opera comique to the Wagner-influenced works of the latter part of the century. Each discussion of an opera begins with a brief account of its performance history, but the major part of the discussion is concerned with what "happened" to the novel (poem, novella, or historical work) when it was transformed into an opera. What did the librettist do to the original story -- how did he reshape it -- to make it something the operatic composer could felicitously handle? The concluding chapter brings together for final discussion the elements in Scott's works that are conducive to good opera -- the pictorial element;

the theme of "opposing fanaticism," often brought vividly to life in one or more major scenes of drama; the well-drawn characters, from both high and low life; the theatrical direct discourse, including soliloquies. In addition, the concluding chapter tries to determine what influence the Scott operas have had on others now in the standard repertoire. Many parallels can be observed because of the use of certain operatic conventions that are part of the common stock of virtually all librettists and composers. Other parallels, however, are directly traceable to the Scott operas. - Jacket flap.

Covering materials published through 1929, it also begins with article from 1859 which do not concern jazz directly, but will serve to present a solid foundation for understanding the American music scene from which jazz developed. Chronologically listed and well-indexed, the hundreds of articles comprise, in effect, a history of jazz as it evolved. Beginning with accounts of Negro music in the pre-jazz era, continuing in an exploration of spirituals, followed by a description of ragtime, we finally learn about the development of jazz from its practitioners and informed audiences of the time.

Krin Gabbard has gathered essays by distinguished writers from a variety of fields. They provide engaging analyses of films such as *Round Midnight*, *Bird*, *Mo' Better Blues*, *Cabin in the Sky*, and *Jammin' the Blues*; the writings of Eudora Welty and Dorothy Baker; the careers of the great lindy hoppers of the 1930s and 1940s; Mura Dehn's extraordinary documentary on jazz dance; the jazz photography of William Claxton; painters of the New York School; the traditions of jazz autobiography; and the art of "vocalese." The contributors to this volume assess the influence of extramusical sources on our knowledge of jazz and suggest that the living contexts of the music must be considered if a more sophisticated jazz scholarship is ever to evolve. Transcending the familiar patterns of jazz history and criticism, *Representing Jazz* looks at how the music actually has been heard and felt at different levels of American culture. With its companion anthology, *Jazz Among the Discourses*, this volume will enrich and transform the literature of jazz studies. Within the last decade music therapists have developed their work with people who have life-threatening illnesses and with those who are dying. This book presents some of that work from music therapists working in different approaches, in different countries, showing how valuable the inclusion of music

The contributors to this book emphasize the importance of working not only with the patient but with the ward situation, friends and family members. Many of the contributors write in their own personal voice, providing a particular insight which will be valuable not only to other music therapists seeking to enrich their own ways of working, but to all those involved in caring for the sick and the dying. Contributors describe their work with both children and adults living with HIV/AIDS, cancer and other chronic degenerative diseases.
