Volume One (of the 2-volume set) is an English translation of the first part of Pierre Viret's commentary on the Ten Commandments published originally in French in 1554 under the title *Exposition familiere sur les Dix Commandemens de la Loy, faite en forme de Dialogues*. It later appeared in a slightly enlarged edition under the title *Instruction Chrestienne en la doctrine de la loy et de l'Evangile*, printed in Geneva by Jean Rivery (1564). The text of this book has been translated from the 1564 edition. With the intention of presenting his readers with an easily-understood, down-to-earth exposition of the Ten Commandments, Viret wrote his commentary as a conversation between two fictitious characters, Daniel and Timothy. Within the work Daniel (representative perhaps of the Old Testament prophets) draws out the truths of Scripture for his disciple Timothy (representative of a young believer in the Gospel era). Viret emphasizes the practical applicability of the Law of God, painstakingly applying the truths of each commandment to the everyday lives of his readers and creating a sound, biblical exposition as applicable today as it was the day it was first penned.

When asked by his barber and good friend, Peter Beskendorf, for some practical guidance on how to prepare oneself for prayer, Luther responded by writing this brief treatise, first published in the spring of 1535. After 500 years, his instruction continues to offer words

Women are completing MBA and Law degrees in record high numbers, but their struggle to attain director positions in corporate America continues. Although explanations for this disconnect abound, neither career counselors nor scholars have paid enough attention to the role that corporate governance plays in maintaining the gender gap in America's executive quarters.

The *Twelve Tables* were literally drawn up on twelve ivory or brass tablets which were posted in the *Forum Romanum* so that all Romans could read and know them. They did not survive antiquity. What we have of them today are brief excerpts and quotations in other authors. *Gaius* (floruit AD 130-180) was a celebrated Roman jurist during the reigns of the emperors *Hadrian*, *Antoninus Pius*, *Marcus Aurelius* and *Commodus*. His *INSTITUTES* are a complete exposition of the elements of ancient Roman law and for this reason are most valuable to the historian of early

institutions. Domitius Ulpianus (died 228), a Roman jurist of Tyrian ancestry wrote in the period between AD 211 and 222. FRAGMENTS of his works survive. As an author he is characterized by doctrinal exposition of a high order, judiciousness of criticism, and lucidity of arrangement, style and language. Julius Paulus (second century AD), also known as Paulus or Paul, was an influential Roman jurist whose OPINIONS feature prominently in Justinian's DIGEST. The Emperor Valentinian II (371-392), a Western Roman Emperor between the years 375-392, names Paulus in the Law of Citations, along with Gaius, Papinian, Ulpian and Modestinus, as one of only five jurists whose opinions were to be followed by judicial officers in deciding cases. The works of these jurists accordingly became the most important reference point for all subsequent legal decisions and profoundly affected the course of European and American law from antiquity to the present. As "the Lawgiver"—endowed with the wrists and hands of a stonemason—engraves the tablets, so he hews the souls of his people: "Into the stone of the mountain I carved the ABC of human behavior, but it shall also be carved into your flesh and blood, Israel..." Mann's tale of the ethical founding and molding of a people sharply rebukes the Nazis for their intended destruction of the moral code set down in the Ten Commandments. But does his famous irony and authorial license mock or enhance the Biblical account of the shaping of the Jewish people? You know the Bible story. Now read Mann's version—it will grip you anew.
